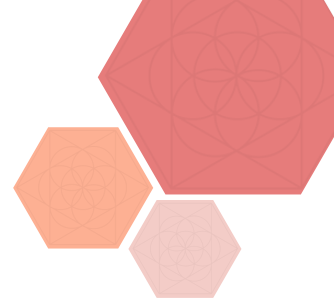

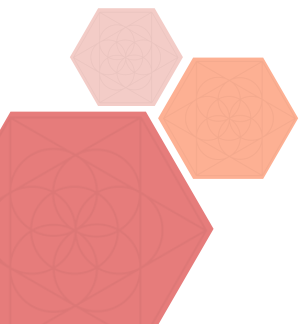

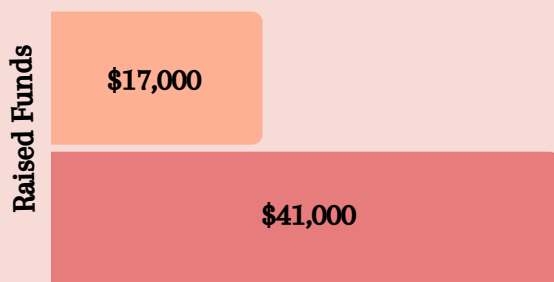

This remarkable growth is a testament to the generosity of our sponsors and the strength of our community. With each year, we expand our ability to provide financial relief and hope to families navigating infertility.

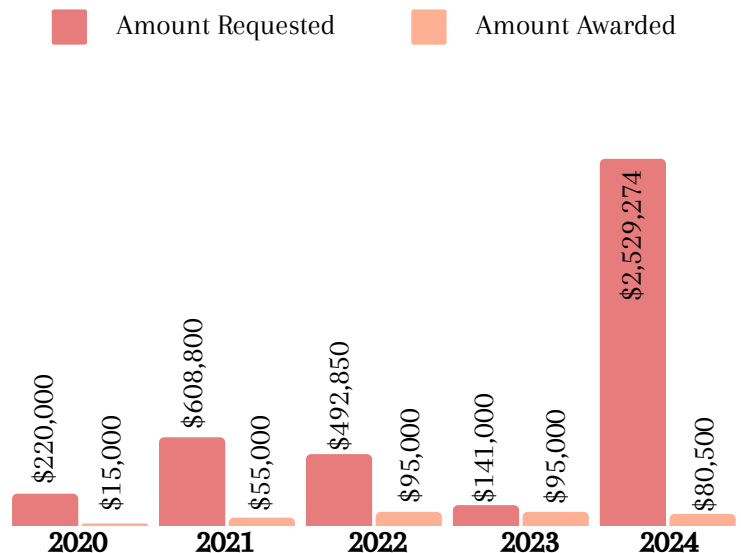
Looking Ahead to 2025: Expanding Hope, Growing Impact

Sponsorship Terms and Conditions

1. Sponsorship. Stork agrees to identify and acknowledge Sponsor as a corporate sponsor as permitted in connection with qualified sponsorship payments under Section 513(i) of the Internal Revenue Code of 1986, as the same may be amended or supplemented (“the Code”) and the U.S. Department of the Treasury regulations promulgated thereunder (“Corporate Sponsorship”). Such identification and acknowledgment will include displaying Sponsor’s corporate logo and certain other identifying information on all promotional materials, correspondence, web and social media outlets, and allowing Sponsor to use Stork’s logo and certain other identifying information on promotional materials relating to Sponsor’s Corporate Sponsorship (“Sponsorship Benefits”). The placement, form, content, appearance, and all other aspects of such identification and acknowledgment will be determined solely by Stork.

2. Mutual License of the Intellectual Property. Stork and the Sponsor are each the sole owner of all right, title, and interest to Stork and the Sponsor’s respective logo and name (“Property”). Stork and the Sponsor hereby grant to other party a limited, non-exclusive license to use granting party’s Property solely in connection with any promotional materials, correspondence, web and social media outlets in relation to Sponsor’s Corporate Sponsorship. Sponsor represents and warrants that it has the full right and authority to enter into this Agreement and to grant the license provided herein; that it has not previously in any manner disposed of any of the rights herein granted to Stork nor previously granted any rights adverse thereto or inconsistent therewith; that there are no rights outstanding which would diminish, encumber or impair the full enjoyment or exercise of the rights herein granted to Stork; and that the Sponsor Property does not and will not violate or infringe upon any patent, copyright, literary, privacy, publicity, trademark, service mark, or any other personal or property right of any third party, nor will same constitute a libel or defamation of any third party.

3. Sponsorship Payment. Sponsor agrees to pay a one-time non-refundable sponsorship payment, due upon execution of this Agreement, to Stork for the amount specified in the Sponsorship Package. This contribution shall constitute payment by Sponsor solely for Sponsor’s Corporate Sponsorship. The use of the Sponsorship Payment is subject to applicants’ medical needs and may be allocated in Stork’s sole discretion.

4. Relationship Between the Parties. The parties agree that this Agreement is not intended to create any joint venture, partnership, employment, or agency relationship of any kind. The parties agree that the Corporate Sponsorship does not constitute Stork’s endorsement, guarantee, acceptance, or approval of Sponsor, its services, products, programs, or activities.

5. Termination. Stork may terminate this Agreement (i) upon Sponsor’s failure to make payment, or (ii) any material breach by Sponsor, including but not limited to use of Stork’s Property in a manner which, in Stork’s discretion could adversely impact perception of Stork and its work. In the event of termination, Stork will refund to Sponsor a pro rata portion of the money that has not been used in support of the Corporate Sponsorship, if any, in Stork’s sole discretion. Except as otherwise provided in this Agreement, upon termination or expiration of this Agreement, all rights and privileges for use of the other party’s Property shall expire, and each party shall discontinue the use of such other party’s Property.

6. Indemnification. Sponsor hereby agrees to indemnify, defend and hold harmless Stork and its agents, officers, directors, employees, attorneys, heirs, successors, and assigns, and each of them, from and against any and all third party claims, actions, demands, losses, damages, judgments, settlements, costs and expenses (including attorneys’ fees and expenses), and liabilities of every kind and character whatsoever, which may arise by reason of: (i) any act or omission by Sponsor or any of its officers, directors, employees, or agents; (ii) any use of Sponsor’s name, logo, Web site, or other information, materials, products, or services provided by Sponsor; and/or (iii) the inaccuracy or breach of any of the covenants, representations and warranties made by Sponsor in this Agreement. This indemnity shall require the payment of costs and expenses by Sponsor as they occur. Stork shall promptly notify Sponsor upon receipt of any claim or legal action referenced in this indemnification section. The provisions of this section shall survive any termination of this agreement.

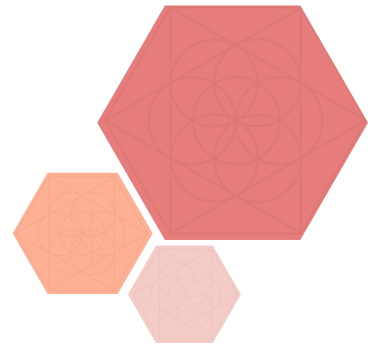
